- Bill Miners: Finance, Parks & Recreation, Charter, Ethics, Docks, Newsletter Finishing up meetings for the dock had the pre bid meeting and no one showed up, no bids have come in they have until the 20<sup>th</sup>. Hope to have work started by March 1<sup>st</sup> and finished in March. Newsletters sent out in the mail today with the water bills. We feel Winterfest was a success, planning a wrap-up meeting.
- Frank Vari: Planning & Zoning, Recycling, Public Relations, Racing Program P&Z elected Lee Adams to continue as Chair and John Watson will continue as co-chair. Attended Cecil Co Chamber meeting in December with Councilperson Morris. Recycling will be picking up Christmas trees in January. Regular pick-up will begin back in March. NY Day Run, 35 sponsors, 153 participated and a profit of over \$4700. Over 100 pounds of food for the food pantry. Thanking donations made at end of year.

Bohemia Trail moving ahead with the design plan out to bid. In front of Bayard house up George to the high school. One way on George has been approved. SHA needs to design a plan but they are on Board for it. We are having CJ to review sidewalk plan. Discussed solution for pavers for Historic District. May be cost effective to do it ourselves instead of their contractors. Discussed amount of maintenance they've been doing. Paving on Biddle & George St hopefully this Spring.

Habersham – update from Tom – Annex into the Town; looking at getting contract on property, need Habersham to consent to the Annex. And go through the process. After annex, subdivide.
